2011 SPRING EXTRAVAGANZA RULES & GUIDELINES

1. Show is held in the Mahan Building and Fine Arts Building on the Fayette County Fairgrounds located at 213 Fairview Avenue, Washington Court House, OH 43160.
2. Booth space will be priced on a per booth basis. Booths are approximately 10' x 10' (100 square feet). Prices are: Chamber Members \$175.00 for first booth, \$140.00 for each additional booth; Non-Chamber Members \$250.00 for first booth, \$200.00 for each additional booth. Booth space includes one six-foot table and two chairs.
3. Booth priority will be assigned on a first come, first serve basis. Every effort will be made to accommodate all exhibitors on location preference. **All fees must be paid before vendor will be allowed to set up display.**
4. **Please inform the Chamber of Commerce office of any electric power or other special needs.**
5. **Set up times** will be Thursday, April 15th between 2:00 p.m. and 8:00 p.m., or Friday, April 15th between 8:00 a.m. and 4:00 p.m. Set up must be completed prior to the Friday, April 15th, 4:00 p.m. opening.
6. **Tear down times** will be Saturday, April 16th between 4:00 p.m. and 8:00 p.m., or Monday, April 18th between 8:00 a.m. and 4:00 p.m.
7. Booth must be occupied at all times by a representative from the participating company.
8. It is essential for all exhibits to be available to the public during all advertised show hours. **No early tear downs.**
